



BY THE KING
A DECREE
JOSEPH R.

WHEREAS Our Royal and Apostolic Majesty's Government has in recent months fallen into a state of inactivity which has in turn damaged the growth and prosperity of Our Realm; and

WHEREAS it is the solemn duty of Our Royal and Apostolic Majesty to ensure that Our Realm continues to develop into an independent community of individuals dedicated to the appreciation of Afrikaner and English culture, the worship of God and the preservation of absolute monarchy by divine right;

KNOW YE THAT WE do hereby enact the following Decree of Koningswyk, and do order all Officers of the Crown to obey and enforce the provisions thereof.

ARTICLE I

Regarding the enactment of a fundamental statute

We do hereby declare that the Kingdom of Natal shall, before the end of the year 2017 Anno Domini, enact a fundamental statute, which shall be the supreme law of Our Realm. Furthermore, We do hereby command Our Lord High Chancellor to draft such a statute in conjunction with Our Royal and Apostolic Majesty.

ARTICLE II

Regarding the creation of the Koninklike Vergadering

We do hereby establish the Koninklike Vergadering to serve as the principal legislative authority of Our Realm, to consist of members appointed by Our Royal and Apostolic Majesty who shall serve at Our pleasure. Furthermore, Our Royal and Apostolic Majesty's Privy Council is henceforth abolished, and the post of Lord President of the Council is henceforth reconstituted as the Lord Speaker of the Koninklike Vergadering.

ARTICLE III

Regarding the reorganization of the provinces and counties

The provinces and counties of Our Realm are henceforth reconstituted as follows:

- The Province of Albertschine, which consists of the Counties of Nassau and Rotterdam;
- The Province of New Bregne, which consists of the Counties of New Essex and Charlestown;
- The Province of New Victoria, which consists of the Counties of Richmond and Sint-Niklaas;
- The Province of Oxford, which consists of the City of Koningswyk and the County of Francilia; and
- The Province of Urquhart, which consists of the Counties of Levinton and New Brabant.

ARTICLE IV
Regarding the Nobility

The titles of nobility of all the Noble Dukes and Earls, excluding those of the Holy Roman Emperor, the Emperor of Austenasia, the King of Uberstadt, the Duke of New Victoria and the Earl of Richmond are henceforth revoked (excluding titles within the Princedom of the Bregentines, the Bregentine Patriciate or the Peerage).

The titles of Marquess Karapavlovic and Lord of St. Cecilia are henceforth abolished.

ARTICLE V
Regarding the Church of Natal

The Church of Natal is henceforth abolished, as it is the belief of Our Royal and Apostolic Majesty that it does not have a valid claim to Apostolic Succession. However, We do hereby establish the post of Chaplain to the Royal Household, who shall be responsible for providing spiritual counsel to Our Royal and Apostolic Majesty and the members of the Royal Family and shall maintain the traditions of the Church of Natal for the sake of advancing Natalian culture, notably the Rite of St. Cecilia.

ARTICLE VI
Regarding the Princess Consort

Her Apostolic Highness the Princess Consort, as our unmarried consort, is to be considered a member of the Royal Family and shall be respected as such. Furthermore, she is henceforth granted the special non-hereditary title of Countess of Koningswyk and is made a Grand Dame of the Most Excellent Order of the Wildebeest.

ARTICLE VII
Regarding the Grand Unified Micronational

We do hereby state the intention of the Kingdom of Natal to pursue observational membership within the Grand Unified Micronational, and do hereby command Our Lord High Chancellor to contact the Chairman of the Grand Unified Micronational to discuss such membership.
